[Israel open fire in the South](#)

Israeli forces opened machine gun fire toward the outskirts of Shebaa, while Israeli drones were flying over [Marjeyoun](#) at low altitude on Monday, June 2.

[Stray dogs in Saida attack a citizen](#)

Citizen Nadine A. was injured after she was attacked by a pack of stray dogs while jogging on the beach in Saida on Monday, June 2. The case was raised to the new municipal council for solutions as several similar incidents have been recorded in the past.

This incident coincides with the recent TNVR (Trap – Neuter – Vaccinate – Return) [plan](#) launched by the Ministry of Agriculture and the Lebanese Veterinarians Syndicate on May 31 in order to address the risk of rabies transmission from stray dogs.

[Conflict between citizens of Siddiqin and UNIFIL patrol](#)

A few citizens from Siddiqin, Tyre fought with a UNIFIL patrol after they blocked the road and stopped the patrol from entering Jabal al-Kabir area without army escort on Tuesday, June 3. The patrol continued its trajectory to the headquarters after an intervention from the Lebanese Army.

[State Security arrests employees from the South Lebanon Water Establishment for abuse of power](#)

Statement issued by the General Directorate of State Security – Media, Guidance, and Public Relations Department on Tuesday, June 3:

In order to protect public institutions and safeguard public funds, the Bint Jbeil office of the Nabatieh Regional Directorate conducted a judicial investigation into employees of the South Lebanon Water Establishment – Bint Jbeil District. This investigation was conducted after information was obtained that they had received money in exchange for facilitating water fee exemption requests for citizens whose homes were demolished in the south.

During the investigation, they admitted to collecting two million Lebanese pounds for each request, while the official fee is one million two hundred thousand pounds, in addition to the value of the fiscal stamps.

[Israeli drone crashes in Kfarkila](#)

According to the Lebanese Army, an Israeli drone crashed in the outskirts of the town of Kfarkila, Marjeyoun, and was transported to the army for inspection on Wednesday, June 4.

[Israeli airstrikes drop bombs and threatening statements over Yaroun](#)

Israeli drones dropped leaflets over Yaroun in Bint Jbeil District directly threatening the town's previous mayor and stating that the mayor is "chosen to serve as an example to others" on Wednesday, June 4.

An Israeli airstrike also threw [bombs](#) at a bulldozer over three phases in the Sultani area southeast of border village Yaroun, Bint Jbeil District.

[Israeli marine forces kidnap a fisherman in Naqoura](#)

For the first time since the ceasefire, IDF forces kidnapped a Lebanese fisherman in Ras Al Naqoura on Wednesday, June 4.

According to the National News Agency, the kidnapping happened after Israeli boats bypassed naval buoys reaching Lebanese territorial waters, surrounded a fishing boat with two fishermen, and [kidnapped](#) one of them.

Thursday
5 June 2025

[Israeli airstrike on Dahiyeh and border villages during Eid Al Adha eve](#)

With tens of airstrikes and rockets, Israeli warplanes attacked [Dahiyeh](#) at night and targeted more than 8 buildings in Hadath, Borj Al Barajneh, and Haret Hreik, after conducting multiple warning raids beforehand on Thursday, June 5.

In the South, an Israeli drone targeted a Rapid car in Burj Qalawieh and [killed](#) one citizen and attacked a building in [Ain Qana](#), Iqlim al-Tuffah that was threatened. Additionally, an Israeli Merkava missile shelled the forests of Yaroun, while Israeli forces dug a trench and created earthen barriers in [Mays al-Jabal](#).

With these attacks, Israel has [broken](#) the ceasefire agreement more than 3,000 times since it came into effect on November 27, 2024.

[One killed and two injured in a family feud in Bhanin](#)

One person was killed, another stabbed, and another injured in a family feud in Bahnin, Minieh in the North, where a fight developed and included the use of bladed weapons and knives on Thursday, June 5.

Friday

[Three citizens injured by Israeli airstrike in Ain Qana](#)

Israeli airstrikes attacked Ain Qana in Nabatieh district and injured three citizens on Friday, June 6.

Simultaneously, Israeli forces conducted a heavy [combing](#) operation on the outskirts of Rmeish and Aita al-Shaab and dropped a soundbomb over a house in Kfarkila.

[Lebanese Army fills a trench dug by Israel in Mays al-Jabal](#)

Statement issued by The Army Command - Directorate of Orientation on Friday June 6:

On June 5, 2025, an Army unit, in coordination with the United Nations Interim Force in Lebanon (UNIFIL), filled in a trench approximately 200 meters long that the Israeli enemy had dug in the outskirts of the town of Mays al-Jabal - Marjayoun on the night of June 4-5, 2025. [...]

[Lebanese Army removes Israeli earthen barriers in Marjeyoun](#)

Statement issued by The Army Command - Directorate of Orientation on Saturday, June 7:

On June 7, 2025, as part of its efforts to monitor the situation in the south and eliminate Israeli violations, an army unit, in coordination with the United Nations Interim Force in Lebanon (UNIFIL), removed several earthen barriers and reopened roads in the outskirts of the town of Mays al-Jabal - Marjeyoun, which the Israeli enemy had previously closed.

[Srifa citizens protest entry of UNIFIL patrol without army escort](#)

Citizens in Srifa stopped a UNIFIL patrol on its way to Wadi Al-Saluqi area, protesting against the absence of army escort with the patrol on Saturday, June 7. The patrol continued its trajectory to the headquarters after an intervention from the Lebanese Army, and no accidents were recorded.

Simultaneously, Israeli forces conducted a combing operation using heavy machine guns on the outskirts of Aita al-Shaab.

[One citizen killed and others injured in Israeli airstrike on Shehabiyeh](#)

An Israeli raid attacked a vehicle between Shehabiyeh and Kfardounin in Tyre district with two missiles, killing one citizen and wounding others on Sunday, June 8.

REPORTING A VIOLATION OF HUMAN RIGHTS TO CLDH

When making a report, please ensure to include the following information:

- **WHERE:** City/village, governorate, additional details (e.g. what prison)
- **WHAT:** Nature of the violation
- **HOW:** A narrative description of what happened
- **WHEN:** Date of the episode (at least the year, if day and month are unknown)
- **TO WHOM:** Information regarding the victim (name, nationality, gender, date of birth, city of origin, phone number). Only share this information with the consent of the person.
- **WHO** is the person reporting (name, phone number) and how were they identified (e.g., victim him/herself, family member, eyewitness, journalist, humanitarian worker...)

The information referred will remain completely private. It will be fact-checked and registered into CLDH's internal system. No action will be undertaken without the explicit and written consent of the reporter.
