[Ministry of Justice approve extradition of wanted man for Beirut Port explosion](#)

Minister of Justice Adel Nassar signed the file for the [extradition](#) of detainee Igor Grechushkin in Bulgaria on Monday, September 22.

Grechushkin is wanted because he is the owner of a ship carrying ammonium nitrate stored at Beirut Port, where it exploded on August 4, 2020.

[Israeli soundbombs near Naqoura and Maroun al -Ras](#)

Israeli drones dropped soundbombs near citizens and homes' rubble in [Maroun al-Ras](#), and on Ras al-Naqoura beach, on Monday, September 22.

[Lebanese Army implement security measures and arrest wanted individuals](#)

Statement issued by The Army Command - Directorate of Orientation on Monday, September 22:

After monitoring and tracking the movement of wanted individuals, security breaches, and infiltration attempts across the northern and eastern borders, army units, each supported by a patrol from the Intelligence Directorate, implemented extensive security measures across various Lebanese regions, arresting 73 individuals as follows:

- The arrest of a citizen wanted for arms trafficking in the town of Aarsal, Baalbek, and the seizure of a large quantity of light and medium weapons, ammunition, and military equipment.
- The arrest of two people in the areas of Mina and Tal, Tripoli, and the seizure of a quantity of drugs.

The seized items were handed over and investigations were initiated with the detainees under the supervision of the competent judiciary.

[One person injured in armed dispute related to real estate](#)

A person opened fire with a combat weapon in Sir al-Dinniyeh and [wounded](#) another on Tuesday, September 23, caused by a real estate dispute between the two.

[Israeli airstrikes open fire towards Bastra and throw bombs in Bekaa](#)

Israeli forces opened fire from the Ramtha position toward the Bastra farm on the outskirts of Kfarshouba on Tuesday, September 23.

Simultaneously, an Israeli drone crashed in [Blida](#) and another dropped two soundbombs on [Marwahin](#) in Western Bekaa, while incendiary [bombs](#) were thrown into Aita al-Shaab and causing fires.

[Jeb Jenin citizens protest police summoning of LBCI correspondent](#)

Journalists and citizens in Jeb Jenin, Bekaa, have organized a sit-in protesting the summoning of journalist Mohammad Ali Ahmad on Tuesday, September 23.

Mohammad Ali Ahmad is LBCI's correspondent in the Bekaa, and he was [summoned](#) by the Jeb Jenin police station on September 22 for covering an incident inside Jeb Jenin prison.

[Israeli airstrike on UNIFIL HQ in Naqoura and Nabatiyeh](#)

According to Lebanese media outlets, UNIFIL Spokesperson Candice Ardel announced that an Israeli drone fell inside the UNIFIL headquarters in Naqoura on Wednesday, September 24, and no injuries were reported.

Ardel noted that the drone was equipped with a camera and not armed, and UNIFIL staff were capable of isolating it, and this attack constitutes "a violation of Resolution 1701 and Lebanese sovereignty."

Simultaneously, an Israeli drone dropped an unknown [object](#) over a valley in Nabatieh twice.

[YASA warns for road safety near Beirut Port](#)

YASA for Road Safety issued a warning of containers falling inside or near the gates of Beirut Port on Wednesday, September 24.

In a post on Facebook, the organization called on the Ministry of Public Works and Transport and the Beirut Port Authority to ensure the safety of people by "investigating and announcing the reasons behind the recurring phenomenon of containers falling"

[Human Rights Committee discusses Israeli aggressions impact on Lebanon](#)

The Human Rights Committee held a session with the Ministry of Foreign Affairs and representatives of Amnesty International to discuss Israeli attacks and their repercussions on Thursday, September 25.

The MPs have agreed to submit recommendations to the Lebanese government and file complaints with the United Nations, the Human Rights Council, and international courts "to halt these actions, as they violate international law".

Ministry of Economy closes meat factory in Taanayel

The Ministry of Economy and Trade [closed](#) a “luncheon” meat factory in Taanayel on Thursday, September 25, due to violations of luncheon beef standards.

Lebanese Army arrested 10 individuals and seized a large quantity of weapons.

Statement issued by The Army Command - Directorate of Orientation on Thursday, September 25:

As part of the security measures implemented by the military institution in various regions, army units, each supported by a patrol from the Intelligence Directorate, carried out raids and arrested eight individuals. [...]

As part of monitoring drug manufacturing and trafficking operations, the Intelligence Directorate in the town of Yanouh, Jbeil, raided the home of a citizen and arrested him. They seized a large quantity of hashish, weapons, and ammunition in his possession.

The Directorate also raided the homes of wanted individuals in the Laylaki area of the southern suburbs and arrested a citizen for forming a drug trafficking and distribution network. A large quantity of drugs was seized in his possession.

During the raid, army personnel were exposed to gunfire, and they responded in kind, without causing any injuries. [...]

Lebanese Army conducts raids in Baalbek

The Lebanese Army conducted raids in the town of Dar al-Wase'a, Baalbek, with the aim of arresting a number of wanted individuals on Friday, September 26, including a wanted citizen that previously fired on army patrols and killed soldiers.

The wanted person was killed after an armed clash between him and army soldiers during the raids.

Landfill smoke from Zahrani causes car clashes

Many cars [collided](#), alongside an army vehicle, due to poor visibility caused by smoke rising from a fire in the Zahrani landfill near Ansariyah neighborhood, leading to multiple injuries on Friday, September 26.

Spy device found in Houla and Israeli soundbomb on Maroun el -Rass

According to the National News Agency, a spying device equipped with surveillance cameras was found in the Hamammir neighborhood in Houla on Saturday, September 27.

Simultaneously, an Israeli drone threw a [soundbomb](#) on Maroun el-Rass.

[State Security seizes shells in Bourj Hammoud](#)

Statement issued by The General Directorate of State Security – Media, Guidance, and Public Relations Department on Saturday, September 27:

Following its intensive intelligence work throughout Lebanon, and after receiving information about the presence of artillery shells in the Hankash area of Bourj Hammoud, a patrol from the Mount Lebanon Regional Directorate headed to the site and seized three 120mm artillery shells. It was found that they were not ready to be detonated, and one of them bore Hebrew inscriptions.

The shells were handed over to the relevant authorities in the Lebanese Army, who worked to remove them from their location.

[Israel throws provocative leaflets in Dahra; shelling in Ramyeh](#)

Israeli drones dropped provocative leaflets near a concrete block factory in Al - Dhahira on Sunday, September 28.

Simultaneously, Israeli [shelling](#) was launched on the outskirts of Ramyeh and Aita al-Shaab at night, and two [soundbombs](#) were thrown on Ras al-Naqoura.

[Rehabilitating heritage buildings in Baalbek damaged by Israeli airstrikes](#)

In a Baalbek tour with the Alliance for the Protection of Heritage (ALIPH), multiple cultural initiatives announced the completion of the first phase of rehabilitating several heritage buildings in Baalbek damaged by the Israeli aggression.

This included the restoration and revitalization of damaged landmarks, restoring their historical and architectural value and enhancing their presence in the cultural landscape.

When making a report, please ensure to include the following information:

- **WHERE** : City/village, governorate, additional details (e.g. what prison)
- **WHAT** : Nature of the violation
- **HOW** : A narrative description of what happened
- **WHEN** : Date of the episode (at least the year, if day and month are unknown)
- **TO WHOM** : Information regarding the victim (name, nationality, gender, date of birth, city of origin, phone number). Only share this information with the consent of the person.
- **WHO** is the person reporting (name, phone number) and how were they identified (e.g., victim him/herself, family member, eyewitness, journalist, humanitarian worker...)

The information referred will remain completely private. It will be fact-checked and registered into CLDH's internal system. No action will be undertaken without the explicit and written consent of the reporter.
